Important Notes:

- 1. Academic Year of First Year B.P.Th faculties will start from 10^{th} January 2022. The Principal of the college shall ensure that teaching as well as practical days / hours shall be covered in the stipulated period.
- 2. The University UG examination of first year B.P.Th for the students admitted in academic year 2021-22 shall be conducted in the month of December 2022.
- 3. Total working available days including examination period are 219 days.
- 4. As per curriculum guidelines, attendance should not be less than 75% of the lectures delivered in each subject of the course of instruction and 85% in practical work for the examination during the total academic period. Attendance in both cases shall be calculated till such date before the commencement of the written examination or up to the end of the academic term, whichever is later.
- 5. During the course of study, actual attendance of the students in theory and practical shall be considered as valid attendance. Participation in any gathering or cultural activities or sick leave or any other leave will not be taken into consideration for calculation of attendance. Hall ticket shall be issued only after fulfilling the criteria of the attendance. It shall be the duty of principal to ensure the correctness of the attendance.
- 6. The principal of the college is empowered to adjust/ make suitable changes in student's vacation to ensure the fulfillment of minimum number of working days.
- 7. The principal of college to notify the tentative schedule of conduct of internal assessment examinations at college level atleast a month in advance.
- 8. The principal of the college is permitted to alter the dates of vacations in order to suite any extraordinary local conditions after taking due approval from University. Nevertheless, minimum number of total working days of the students shall be fulfilled as per requirement of the University of the Academic Year.
